### Easy to Use

Getting benefits from SoonerSelect Children's Specialty Program is easy. We believe the best way for you to keep good health is to develop a good relationship with your family physician. That is why you, and any of your family who are members of Oklahoma Complete Health, need to choose a Primary Care Physician, or a Clinic that has multiple PCPs.

When you need care, start with a call to your PCP for an appointment. Tell them you are covered by SoonerSelect Children's Specialty Program. If needed, your PCP will make a referral for specialized care. It's that simple.

### Accessibility

If you use a wheelchair, walker, or other aids and need assistance getting into your provider's office, call their office before you get there. This way someone will be ready to help you when you get there. If you would like help talking with your provider about your special needs, call Member Services at **1-833-752-1665** (TTY: **711**).

### Telehealth

Telehealth is your convenient, 24-hour access to in-network Oklahoma Complete Health healthcare providers for non-emergency health issues. It's available for you to use when you're at home, in the office or even on vacation. Before you can use Telehealth, you need to have an account through the member portal. ## If You Have to Be Hospitalized

If you need hospitalization, your PCP or a Specialist will admit you to a hospital where he/she is affiliated. The hospitals you would be admitted to are listed in this directory.

## Immediate and Emergency Care

With SoonerSelect Children's Specialty Program, you have access to medical services 24 hours a day, 365 days a year. If you have a serious illness or injury that needs immediate attention, first call your PCP. They know your medical history best.

**In the event of a potentially life-threatening emergency, call 911.** Or go to the nearest emergency room. If you are admitted to the hospital, they will call Oklahoma Complete Health within 48 hours to notify us of your medical situation. Or you can have someone else call for you. If you are experiencing emotional or mental distress, call the Oklahoma Mental Health Lifeline at **988**, 24 hours a day, 7 days a week, to speak with someone who will listen and help.

Some examples of emergencies are:

- Severe pain of any kind
- Change in mental status
- Change in neurological status
- Complications of pregnancy
- Chest pain
- Poisoning
- Acute allergic reactions
- Severe shortness of breath
- Abdominal Pain
- Multiple episodes of vomiting or diarrhea
- Bleeding that won't stop
- Injuries that cause loss of function to a body part
- Symptoms of substance abuse
- Psychiatric disturbances
- Overdose of medication

**Si se trata de una emergencia que podría poner en riesgo su vida**, llame al **911**. O bien, diríjase a la sala de emergencias más cercana. En caso de hospitalización, llamarán a Oklahoma Complete Health dentro de las siguientes 48 horas para notificarnos su situación médica. También puede pedirle a otra persona que llame por usted. Si está experimentando molestias o problemas emocionales o mentales, llame a la Línea para Emergencias de Salud Mental de Oklahoma al **988**, las 24 horas del día, los 7 días de la semana, para hablar con alguien que lo escuchará y le brindará ayuda.

Los siguientes son algunos ejemplos de una emergencia:

- Dolor intenso de cualquier tipo
- Cambio en el estado mental
- Cambio en el estado neurológico
- Complicaciones durante el embarazo
- Dolor de pecho
- Intoxicación
- Reacciones alérgicas agudas
- Falta de aire grave
- Dolor abdominal
- Episodios múltiples de vómitos o diarrea
- Sangrado que no se detiene
- Lesiones que causan pérdida de funciones en una parte del cuerpo
- Síntomas de abuso de sustancias
- Trastornos psiquiátricos
- Sobredosis de medicamentos

P	Parking	Parking spaces and van-accessible space(s), are accessible. Curbs to on-site parking, public transportation, and the side walk at the site entrance have curb ramps.
EB	Exterior Building	There is an accessible ramp to the building. Curb ramps and other ramps to the building are wide enough for a wheelchair/scooter. There are handrails on both sides of the ramp. Doors are wide enough for wheelchair/scooter to enter and the doors have handles that are easily opened.
IB	Interior Building	Doors are wide enough for a wheelchair/scooter and have handles that are easily opened. There are interior ramps that have handrails. If an elevator is present, it must be free for public use. The elevator has easy-to-hear sounds and Braille buttons within reach. The elevator is large enough for a wheelchair/scooter to turn around. The restroom is accessible, has doors wide enough for wheelchair/scooter and are easy to open. Offices have accessible equipment and clear for space where the equipment is for side transfers by wheelchair or scooter users. Lift equipment exists when needed. If office has a chair lift, it can be used without help.
PA	Programmatic Access	Programmatic access includes, but is not limited to: accessible communication and materials in other formats given in a timely manner, staff help with follow-up visit planning, and other disability-related support (people with disabilities who cannot wait in waiting room are seen right away).
~	Rx	This pharmacy can provide an extended day supply.






